FPT'S BUSINESS PERFORMANCE IN 4M2017

Ending the first four months of 2017, FPT recorded consolidated revenue of VND 12,975 billion, up 13% YoY, equal to 104% of the year-to-date (YTD) target. Profit before tax (PBT) has increased by 14% YoY to VND 904 billion, which was equal to 108% of the YTD target. Profit after tax (PAT) was VND 759 billion, up 18% YoY.

Both year-to-date PAT attributable to parent company's shareholders and year-to-date EPS have increased by 15% YoY, to VND 581 billion and VND 1,264, respectively.

Profit growth of FPT continued to be driven by the two core businesses including Technology and Telecom sectors, which altogether accounted for 75% of the consolidated profit before tax of the group. More specifically, year-to-date profit before tax of the Technology and Telecom sectors increased by 48% and 20% YoY, respectively.

The Distribution and retail sector has achieved 104% in terms of both revenue and PBT targets for the year to date, in which, the retail segment continued to perform outstandingly in the four months, with its revenue up 31% and profit before tax up 45% YoY.

During the reported period, FPT's overseas markets recorded revenue of VND 1,963 billion, up 16% YoY, and PBT of VND 284 billion, up 15% year on year.

- ❖ FPT introduces key technology in the anniversary of Osaka office: On April 19, FPT Japan held the 10th anniversary of Osaka office. The event was attended by Vietnamese Consul General in Osaka Tran Duc Binh, representative from the Osaka Chamber of Commerce Masaki Fujita and Industry and more than 100 guests representing FPT's business partners from Osaka, Tokyo and many other areas.
- FPT discusses win-win cooperative model with 150 directors of French groups: On April 26, 2004, FPT co-operated with IE-Club and La Poste Group to organize a workshop on Vietnam and the 4th Industrial Revolution FPT with win-win cooperative model for French partner.

FPT Japan get big win in Sendai: Japanese language and technical skills helped FPT Japan beat its competitors from South Korea and China to win a value contract with a multinational computer technology company based in Sendai (Japan).

- ❖ FPT Software named AWS's Technology Partner of the Year: FPT was recently honored to be named as "Technology Partner of the year" by Amazon Web Services (AWS) at the AWS PHA Singapore 2017.
- ❖ FPT IS deploys SAP to the most customers in Vietnam in 2016: FPT IS has recently been honored as the most customer deployment partner in 2016 by SAP. This is the first time that FPT IS was honored in this category.
- ❖ FPT IS and FPT Software listed in Top 10 Sao Khue: On April 15, at the ceremony of announcing and awarding the 2017 Sao Khue Award held by VINASA, Software outsourcing and intelligent transportation fees services were honored in Top 10 list.
- ❖ FPT scored maximum point for transparency criteria including corporate and owner: On April 26, 2017, Towards Transparency launched Transparency in Corporate Reporting: Assessing the 30 largest companies in Vietnam (TRAC Vietnam 2017). According to this report, FPT is one of the two enterprises being ranked the first position with a maximum point of 100% on the transparency criteria including corporate and ownership structure.

- ❖ Next generation cloud computing service FPT HI GIO Cloud launched: On April 13, 2017, FPT Telecom International Co., Ltd (FTI) under FPT Telecom JSC has launched the next generation cloud computing service called FPT HI GIO Cloud, which is for the first time being offered with a comprehensive scale and features to individual customers and businesses.
